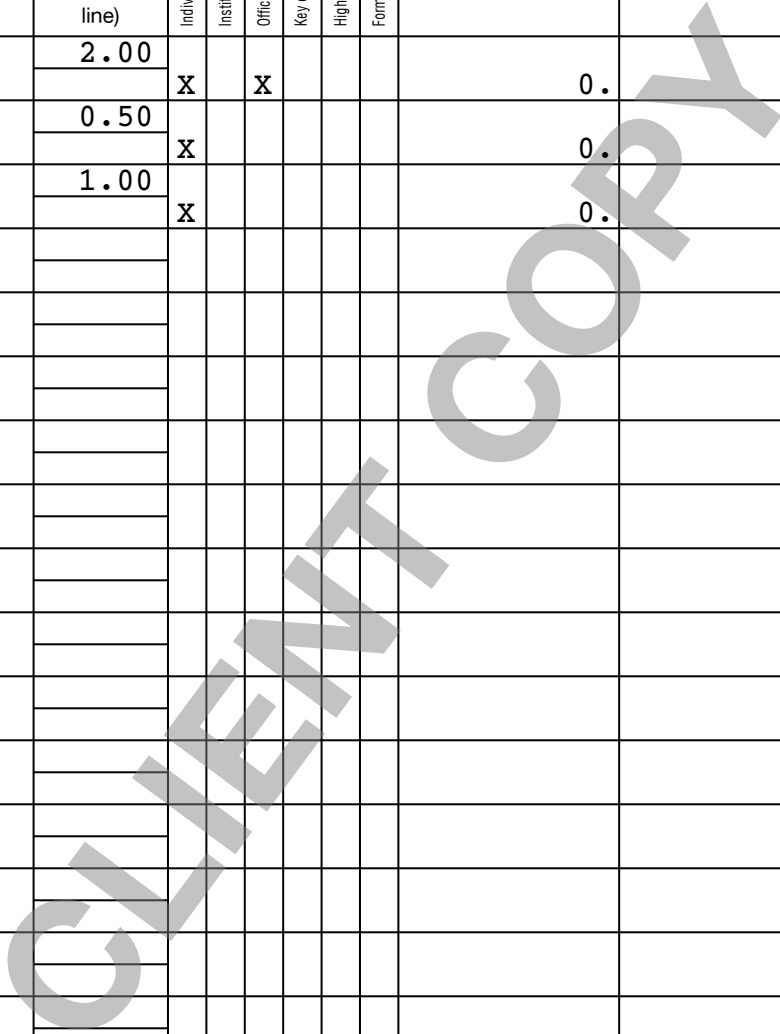

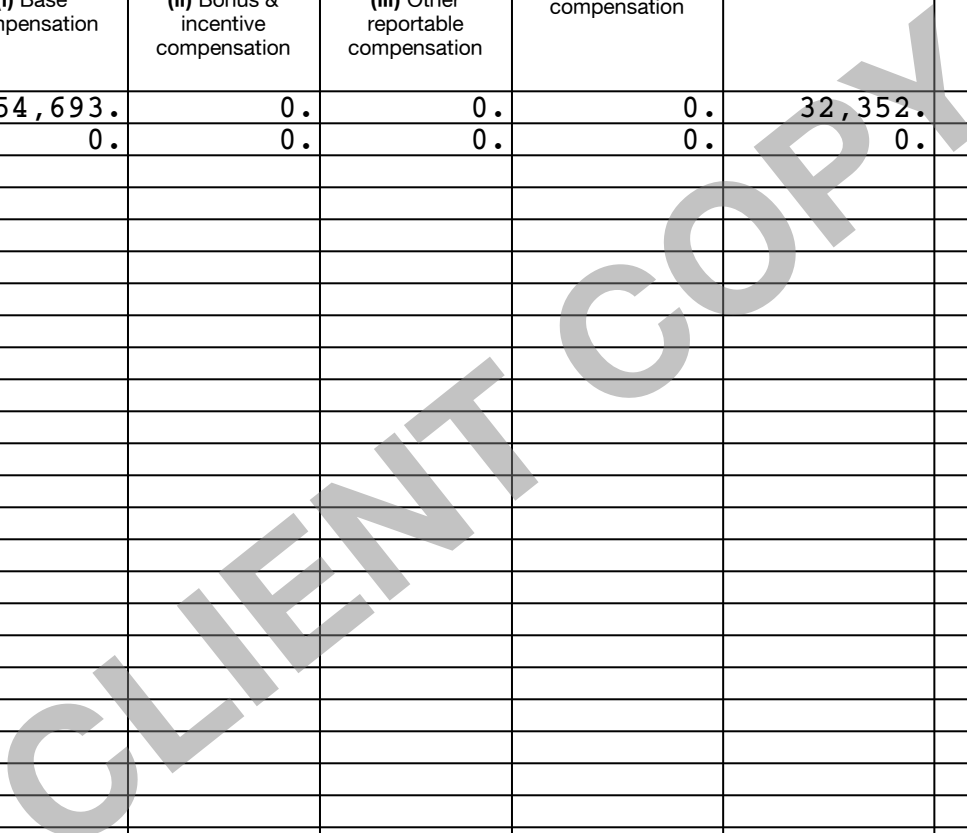

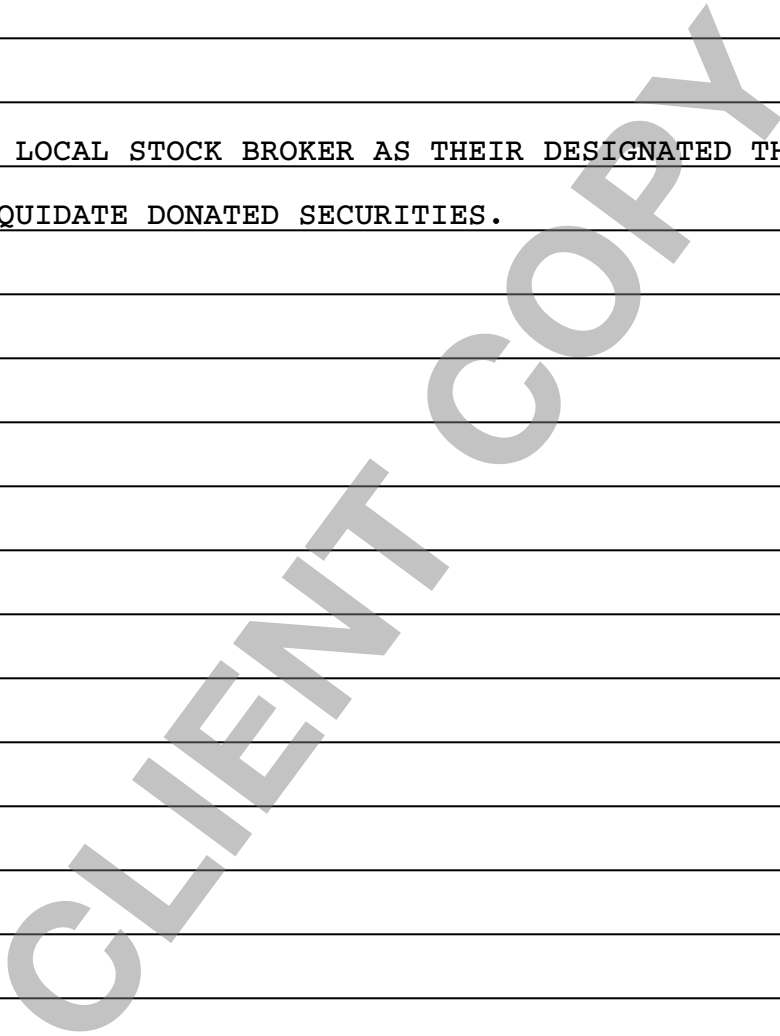

IN FY21, THE CLUB RAISED 72% OF FUNDS NEEDED TO SUPPORT THE NEXT FIVE YEARS OF THE LIVING WAGE INITIATIVE AND ACCELERATE ITS START DATE TO JULY 1, 2021. THE CLUB IS ALSO INVESTING RESOURCES TO HAVE THIRD PARTIES CONDUCT INTERNAL DEI ASSESSMENTS THAT PRODUCE DATA TO INFORM UPDATED ORGANIZATION POLICIES AND CREATE A MORE INCLUSIVE WORKPLACE.
